In Bhandara District, The whole population of rural area is 9,60,463 (85%) and whole labour were 2,29,76.5 (31.20%) of the year 2001-2010.

So, In Bhandara District Maharashtra Gramin Employment Gurantee Scheme had selected that (for the session 2001- 2010) there were total average in 2001 were 59.96%, in 2002 were 52.30%, and in 2010 were 59.60%.

presents in Mohadi than other tahasil in Bhandara District and the percentage
were 75.16%, of the year (2001-2010) and the total average of women
labour were 31.78 %.

Maharashtra Gramin Employment Gurantee Scheme had selected that, the total average of the labour who has got 100 days employment were 61.64 % in the year 2007-08, and 60.11% in the year 2009-10 . and the whole average is 9,03,329.

After reading of **chapter third** we can say that In Bhandara District Maharashtra Gramin Employment Gurantee Scheme in level planning the total work of Grampanchayat is 4,142 in tahasil level is 7,348 and District level 471 In State level 2,031 So in Maharashtra Gramin Employment Gurantee Scheme in level planning the total work number is 3,524.
